#### **HOW THE SALE WILL RUN:**

1. The bidding will remain open from 12 Noon to 4PM Eastern on Saturday Oct 8<sup>th</sup> and Sunday Oct 9<sup>th</sup>, 2016 –
2. You may bid any amount that you want
3. The Sale is "First Come First Serve".
4. Bidding on each horse will remain "Open" for 30 minutes from the time that the first offer is received
5. When you Text or Email Provide Complete Details of Your Bid Including Your Name, Horse's Hip # and Offer - this will give us a time stamp
6. In the event that there are multiple offers on the same horse during this 30 minute period:
  - A. The best offer at or above the asking price will be accepted
  - B. If the offer is below asking price, Robin DeGraff in her sole discretion has the right to refuse/accept said offer
  - C. If two or more bids are for the same amount, at or above the asking price, a silent auction will be held immediately between those parties at the completion of the 30 minute open bid period. We will make our best efforts, however, any parties that are not present must be immediately available by phone, to text us a valid credit card for the purchase amount of your silent auction bid, and also your bid amount. We are not responsible if you are unavailable or unreachable. We will have an independent person to review the submitted amounts and the best offer will be accepted.
7. Payment
  - A. To be in the form of Cash or Certified Check for any horses that will be picked up the day of the sale. A \$30 upcharge for same day Coggins may apply as not all farm horses have current Coggins.
  - B. Personal checks and Credit Cards will also be accepted for the full purchase price of the horse (3% Convenience fee applies). Purchaser must forward completed DeGraff Stables Credit Card Signature Authorization form. Text photo of signature page is acceptable and/or scan and email. The horse may not leave until the person check or credit card charges have cleared.
  - C. Sales Tax if applies will be due over and above the Purchase amount and is responsibility of Buyer
8. 2016 Dispersal Sale Notes – Buyer responsible to review and is bound by Disclosures and/or special terms on the 2016 Dispersal Sale List of Horses with Hip Numbers and Asking Prices as well as the 2016 Sale Horse Disclosure List for additional terms and conditions that apply to the sale.
  - A. Horses are available for public viewing in person at the farm October 7, 8 & 9 by appointment. Call Robin to arrange 419.573.9098.
  - B. All Buyers, Visitors, Veterinarians, etc. to the farm will be required to fill out a DeGraff Stables Registration Form and a DeGraff Stables Release and Indemnification Form
9. Board – All buyers to execute a DeGraff Stables On Farm Board Contract that is in effect until horse is picked up
10. All bidders must be 18 years or older
11. In all instances, Robin DeGraff will have final determination on any issues.
